The use of the ecolabel in other Nordic countries is included by this licence without separate registration. The turnover of the specified products shall once a year, on request, be reported to the ecolabelling organisation by 1 April at the latest. Turnover shall be broken down by Nordic country.

The ecolabelling organisation undertakes to inform licensees if any amendment is made to the criteria document.

The licence will be revoked with immediate effect if the "Regulations for Nordic Ecolabelling of products" or the ecolabelling criteria for the product group are disregarded. If the licensee causes the ecolabelling organisation direct or indirect costs as a result of this or if damage is caused by a product manufactured/sold by the licensee, the licensee shall indemnify the ecolabelling organisation in full.

The ecolabelling licence is valid up to the specified date unless written notice of cancellation is issued by the licensee or the ecolabelling organisation at least three months in advance. The licence is non-transferable unless an application for transfer is submitted.
